6. Venue: Pickleball Hall, King Square Sports Center
7. Capacity: 32 Pairs/Team per event
8. Ball and Court: ONIX Indoor Pickleball, hardwood floor
9. Eligibility: Any pickleball enthusiast, regardless of age, gender, level, residence, walk of life etc. can participate in the corresponding event.
10. Team Requirements: Each team shall consist of three pairs of doubles, which are women's double, mixed double and Men's Double, with a total of 5~7 members. The female player who plays Mixed Doubles are allowed to play Women's doubles as well
11. Fees: Before April 12 \$80 per doubles pair, \$240 per mixed team
After April 12, \$100 per doubles pair, \$280 per mixed team.

14. Competition Rules:

a. Rally scoring, one game determines the winner. In the group round robin matches and Division B elimination matches, the first team to score 15 points wins the match. When a team scores 7 points, the two teams will exchange ends. When a team reaches 14 points, the team must hold the right to serve in order to win the last point. In Division A elimination matches, the first team to score 21 points wins the match. When a team scores 10 points, the two teams will exchange ends. When a team reaches 20 points, the team must hold the right to serve in order to score. If the score reaches 20-20, then the team leading by 2 points wins the game. If 24-24, the team reaching 25 points wins the game.

b. The competition in all events will be organized in two stages: group round-robin and knockout.

Stage 1: The participating pairs/teams will be divided into eight groups of four pairs/teams each, and will compete in a round-robin to determine the ranking of the groups, with the first and second places of the groups advance to Division A, and the third and fourth places going to Division B.

Stage 2: Elimination matches will be held in Division A and Division B respectively to determine the final ranking. Each pair/team will have at least 4 matches per event to play.

c. There will be three matches in each set of inter-team matches in the following order: Match 1: Women's Doubles; Match 2: Mixed Doubles; and Match 3: Men's Doubles. Each player is allowed to play only once in a team match except for one female player, who is allowed to play in both women's doubles & mixed doubles

d. One time-out of one minute is allowed for both parties per individual match. The pair/team calling the time-out can reposition two players, and both teams can reposition two players when exchanging ends at the half-time
